# MURRUMBIDGEE CATCHMENT MANAGEMENT AUTHORITY

Natural Resources Minister Craig Knowles today announced that Lee O'Brien will Chair the Murrumbidgee Catchment Management Authority. The principal office for the Murrumbidgee Catchment Management Authority (CMA) will be in Wagga Wagga.

"Lee was appointed on merit, based on individual skills and experience, not on his representation from a particular interest group. Lee operates a successful cropping and merino sheep business at Henty. Through his involvement in the Murrumbidgee Regional Assessment Panel he is fully conversant with funding requirement of the NHT/NAP funding programs. Lee was an active member of the former Murrumbidgee Catchment Management Board for over 4 years. "He will work on behalf of the catchment community in managing natural resources. While reporting directly to me, he will provide leadership and strategic direction to the CMA Board. "The CMA is the primary vehicle for the delivery of simpler and more efficient land management practices. "Funded by the State and Commonwealth Governments, the CMA will strive to meet the needs of the catchment community to achieve the best natural resource outcomes.

"Wagga Wagga is the logical choice to base the Murrumbidgee Catchment Management Authority as it is central to the catchment, has access to infrastructure networks, is within close proximity to other major Government departments and uses existing Government accommodation" Mr Knowles said.

It is anticipated that the Wagga Wagga office will be open by the end of March 2004, following the appointment of the CMA Board members and General Manager.

"Close collaboration with catchment communities will be fundamental to the success of the CMAs.

"The next stage in setting up the CMAs is the selection of CMA Board Members and General Manager. Short listing of candidates will occur immediately with interviews to be held in upcoming weeks.

"The Local CMA Establishment Team will continue to support the CMA Chair during this 'start up' phase" Mr Knowles said. The Murrumbidgee Catchment Management Authority has been allocated \$13.4 million to spend on priority natural resource management projects in their area during the remainder of 2003/2004 financial year.

"The funds, provided by the State and Federal Governments, will be allocated on the basis of the Investment Strategies submitted by the Local CMA Establishment Team," Mr Knowles said.
